## **TREASURER'S REPORT:**

Karen Grant presented her report.

Balance of Working Account \$12,358.27; Term Deposit x 2 balances \$10,000.

# CAPTAIN'S REPORT – read out by Acting Captain Trish Gray File attached

Moved Trish Gray and seconded by Colleen McRae that the report be accepted.

## **GENERAL BUSINESS:**

- SWLGA vs RWGA change in format 2023
  - Message received from SWLGA was: "After discussion the general feeling was we still have Division 1, 0-18.4 and Division 2, 18.5 – 25 as scratch teams and 7 members per division. That we possibly include a third scratch division for HCP's 25.1 to 35 and above with 7 players as well."
  - After much discussion a motion was put to the meeting:
  - o Motion from Helen Foster:
    - That, in terms of Bernie McLean's letter of July 27 2022 regarding the Inter Association Match, that we keep the format as is with two teams of nine. Make due consideration for a third division group on another day.
  - Seconded by Yvonne Couper
  - Life Member Carolyn Martin spoke for the Motion. She asked that we retain one prestigious event for the
     District with 18 players.
  - The Motion was passed unanimously. RWGA vs SWLGA to remain as two divisions.

- Pennant A letter was tabled from Henty Golf Club responding to the communication from Thurgoona Golf Club regarding late finish issues caused at times by squaring of Matches.
  - General Discussion was held regarding squaring of Matches or playing on to get a result.
  - Motion from Helen Foster:
    - That in Riverina Pennant we play on all Matches, no squares.
  - o Seconded by: Ann Webber
  - Motion Passed.
  - Note: Thurgoona voted against the motion
- President Trish Gray announced that as we currently have no nominations for both President and Captain that Janelle Doust has an option to present.
  - Janelle handed out an information sheet "Suggestion for a Trial Change to the RWGA Executive for 2023".
     Sheet attached.
  - There were favorable comments from the room. It was suggested that we introduce updated Terms of Service to stagger changes to the Board with transition to the new system to take place if required. The Constitution to be amended at the conclusion of the Trial if needed. Meralyn Fage spoke in support of RWGA retaining control of our own District.
  - o Motion from Janelle Doust:
    - I move that in the event of there being no nominations for President and Captain at today's ADM, that we trial the proposed move to the new Board arrangements for 2023. The Constitution will be amended at the end of the trial if the Board arrangement is to be adopted permanently.
  - Seconded by Christine Harrison
  - Motion passed unanimously
- General discussion re Affiliation Fees and issues for non-Riverina clubs.
  - The general consensus was that Clubs who left RWGA to join with WRDGA (Deniliquin, Finley, Berrigan,
    Jerilderie and Hay) were no longer in the RWGA so were not able to play in our Pennant Competition. These
    Clubs are welcome to play in individual events run by RWGA.
  - Carolyn Martin spoke to affiliation issues and agreed that Clubs need to be affiliated with RWGA to be entitled to play in RWGA events.
